IT IS ORDERED that:

1. the Defendant's application for permission to Appeal be refused
2. the Defendant be restrained by way of final injunction from publishing or causing the publication of the following allegations of and concerning the Claimant or any





other allegations to the same or a similar effect

ALLEGATIONS RESTRAINED

That the Claimant is:-

- a) racist
- b) sexist
- c) homophobic
- d) a member of the BNP, EDL or any fascist party
- e) a paedophile or a person with paedophile tendencies
- f) a person who posts indecent images on the internet
- g) a habitual drunkard and/or
- h) financially dishonest or corrupt

For the avoidance of doubt the word “publishing” includes publication in written, pictorial or spoken form and includes making the allegation available to be read or seen on the internet or via social media

3. there be liberty to apply to the Court to vary or discharge this injunction by reference to any future words or conduct by Mr Reynolds
4. the Appellant/Defendant to pay the Respondent/Claimant’s costs of today summarily assessed in the sum of £200 such costs to be paid within 28 days of the date of this Order
